Wasatch Adaptive Sports served over 500 students of which 87% received lessons on scholarship assistance. Nearly 200 new individuals participated in the program in December through April alone as the program connected with new referring partners and continued to spread awareness of its programs. WAS students reported improvements in confidence (95% of respondents), self-esteem (90%), overall mental health (88%), independence (80%), quality of life (78%), and strength (76%) as a result of program engagement. WAS officially launched a equipment rental program and adaptive yoga program to total 13 programs geared toward promoting independence and active living through recreation.
